Residential Water/Sewer Tax: \$360.00 per unit

Water only 60% of rate, Sewer only 40% of rate

Subsidiary Apartments: \$360.00 per year

Apartment building up to 20 units: \$360 per unit.

Cottages and vacation homes pay residential rate.

Commercial Water/Sewer Tax: \$400.00 per unit

Water only 60% of rate, Sewer only 40% of rate

Institutional: \$3,500 per year

Senior care residences: \$400.00 per four resident units or portion thereof

Bed & Breakfast's: \$400.00 per year for every four bedrooms or portion thereof

Hotels, motels and efficiency units: \$400.00 per year for every three units or portion thereof

Fish processors: \$110,000.00 per year

Fish offloading facilities: \$3000

- ❖ All taxes are due and payable when billed.
- ❖ All taxes shall be billed for the full year.
- ❖ Interest, compounded monthly, shall be charged on all previous years taxes and shall accrue on any unpaid current year's taxes unpaid as of May 31<sup>st</sup>, at the rate of one percent per month.

❖ Exemption for Senior Citizens:

A discount of 15% will be available on Residential Property Tax for Senior Citizens subject to the following conditions:

1. All prior year's taxes, including Water and Sewer Tax must be paid in full;
2. Current property taxes must be paid by May 31<sup>st</sup> of current tax year;
3. Applies to one property within the Town, in which the resident lives: full time or seasonal;
4. If property is in joint names, one owner must be over 65 years of age as of January 1<sup>st</sup> of current tax year;
5. A copy of birth certificate or other identification must be provided if requested.

**Payments may be made:**

At the Town Office: by cash, cheque or debit;  
 Mail: by cheque, bank draft or money order.  
 Your employer may offer payroll deductions.

**Water Service Turn on and off fees:**

- Turn on and off during regular working hours -\$25.00  
 (Once each year the fee for the above will be waived per household)
  - Turn on and off after hours/holidays/weekends - \$75.00
- Please call the Public Works department at 266-1320 to have your water service turned on or off.
