A. Call to Order:

- As Returning Officer for the Town of Fogo Island, Deputy Town Clerk Daphne Coles chaired the meeting and called to order at 7:01PM.
- Deputy Town Clerk welcomed everyone that was viewing the meeting on the ZOOM Platform and offered congratulations to the new candidates.

B. Oath of Office

- I. Returning Officer Daphne Coles, conducted the swearing-in of all five new Councilors, in which they received their Oath of Office in the following order:

 - c) David McKena
 - d) Lary Roebotham
 - e) Damian Roebotham

C. Nominations

Nominations for Mayor

- a) Returning Officer, Daphne Coles opened the table for nominations for position of Mayor.
- b) First call for nominations was issued and none were received.
- c) At the second call for nominations, Councilor Andrew Shea was nominated by Councilor Damian Roebotham, seconded by Councilor Holly Payne. Councilor Andrew Shea accepted the nomination.
- d) One more call for nominations for Mayor was made, none were received and nominations for Mayor ceased
- e) With only one nomination for Mayor, Returning Officer declared Councilor Andrew Shea as Mayor, and offered congratulations on the new position.

Deputy Mayor

- a) Returning Officer, Daphne Coles opened the table for nominations for position of Deputy Mayor.
- b) At the first call for nominations, Councilor Damian Roebotham was nominated by Mayor Andrew Shea, seconded by Councilor David McKenna. Councilor Damian Roebotham accepted the nomination.
- c) At the second call for nominations, Councilor David McKenna was nominated, moved by Councilor Lary Roebotham, seconded by Councilor Damian Roebotham. Councilor David McKenna accepted the nomination.
- d) One more call for nominations for Deputy Mayor was made, none were received and nominations for Deputy Mayor ceased.
- e) With 2 nominations for Deputy Mayor, a vote by secret ballot took place by Councilors and votes were returned to the Returning Officer for counting. Results were:
 - i. Councilor David McKenna 1

- ii. Councilor Damian Roebotham 4
- f) Returning Officer declared Councilor Damian Roebotham as Deputy Mayor and offered congratulations on the new position.
- When election of Mayor and Deputy Mayor was complete, Deputy Town Clerk stepped down from the Chair and Mayor Shea took the position of Chair.
